# Contest Rules and Regulations

1. Contestants must be at least 21 years of age. A copy of a photo ID must accompany your contest application.
2. Contestants are required to reside in Alameda County or a neighboring county where there is not an existing leather title contest. Proof of contestant's residency must be shown and a copy submitted with the application. No P.O. Boxes are accepted.
3. Mr. & Ms. Alameda County Leather titleholders are members of the Board of Directors of Alameda County Leather Corps (ACLC). Mr. & Ms. Alameda County Leather titleholders are required to become a member of ACLC and attend all meetings as per the ACLC Bylaws. A copy will be given to you upon request.
4. Mr. & Ms. Alameda County Leather titleholders are entitled to attend or compete in the International Mr. & Ms. Leather contests or Ms. World, upon completion or reasonable implementation of their listed duties. In the event they win one of these titles, they may be required, based on the decision of the board, to turn the Alameda County Leather title over to the First Runner-up of the Alameda County Leather title contest for that year.
5. Mr. & Ms. Alameda County Leather titleholders agree to represent the East Bay and ACLC at other events in the Bay Area and elsewhere as approved by the ACLC Board of Directors.
6. Mr. & Ms. Alameda County Leather titleholders can not hold concurrent titles. If another title is desired, you must seek board approval and you may be required to turn the Alameda County Leather title over to the First Runner-up of the contest for that year.
7. Mr. & Ms. Alameda County Leather titleholders are required to host **a minimum** of three (3) ACLC fund-raisers during their title year. They must also agree to assist in the production of the next year's title contest. Upon completion of the planning and reasonable implementation of the three fund-raisers, ACLC agrees to host a fundraiser to assist in travel expenses for the International competitions.
8. The ACLC Board of Directors must approve all events that utilize the name of Alameda County Leather Corps. Titleholders may use their titles for events and appearances without ACLC Board of Directors approval.
9. Mr. & Ms. Alameda County Leather titleholders may host their required events either individually or in conjunction with each other or others. These required events must be ACLC sponsored events as well.
10. Titleholders are the representatives of Alameda County Leather Corps and as such are subject to the ACLC Bylaws and the procedures set forth by the ACLC Board of Directors.
11. To avoid a conflict of interest, any person who currently holds another title must seek ACLC Board of Directors approval before entering this contest.
